

Family Treasure Hunt competition terms and conditions:

This competition is open to children and young people aged 6 – 16 years old. There are three age groups, A 6-9 year olds, B 10-12 year olds, C 13- 16 year olds. A winner will be selected for each age group and each winner will receive the Prize.

This Brighton treasure hunt takes in all the best, from the Royal Pavilion, through the centre and the tiny winding Lanes, then down to the seafront to finish with some fun on Brighton Pier.

Challenge:

Write a review of your day out at The Warren.

A 6-9 year olds.

The review must be submitted with the name of the entrant and parent/guardian name and contact telephone number, so that Otherplace Brighton staff can call them to notify in case of a win.
